I-20 Certification of Finances for Harvard Summer School

Prospective F-1 students must have the financial resources to live and study in the United States. This includes being able to cover the cost of tuition, books, and living expenses. Harvard Summer School must collect evidence of the student's financial ability before issuing a *Form I-20 Certificate of Eligibility for Nonimmigrant Student Status*. Harvard Summer School students who are not United States citizens or permanent residents must complete and submit this *Certification of Finances Form* to the I-20 Document Portal by **May 1, 2023**. Without complete information and appropriate certification, the I-20 cannot be issued.
